MAP Policy

Car Planet Detailing Products LLC (Carplanet) has instituted a Minimum Advertised Price policy (MAP) for the benefit of all of our valued resellers. Although we actively encourage and support the advertising and promotion of our products by our domestic dealers and distributors, we find it necessary to implement a MAP policy so that our brand name is not devalued in the marketplace, and so each Carplanet partner can compete equally on the basis of the value they provide the customer, whether that be product knowledge, service, training, support, inventory or any combination of these items and more.

This document outlines the MAP policy for all Carplanet Detailing Products.

1. An authorized Carplanet reseller shall be deemed in violation of this MAP policy if they advertise, or otherwise place in the public domain, prices for Carplanet products that are below 20% off retail price.
2. This MAP policy applies only to advertised prices. Carplanet LLC does not and will not impose or enforce any policy with respect to the actual re-sale price of the product, and the authorized reseller is free to sell Carplanet products at any price and terms it deems appropriate.
3. This MAP policy applies to all advertisements of Carplanet individual product SKUs, and includes but is not limited to magazines, websites and other electronic media, broadcast emails, catalogs, flyers, coupons, newspapers, television and radio. The policy does not affect any in-store advertising or in-store actual product pricing.
4. Pricing listed on an internet site is considered an "advertised price" and must adhere to the MAP policy. Once the pricing is associated with an intent to purchase (added to shopping cart or order), the price becomes the selling price and is not bound by this MAP policy. Statements such as "add to basket to see price", "we will match any price", and "call for price" are acceptable.
5. From time to time, Carplanet LLC may choose to offer special promotions on certain products. In such an event, we reserve the right to modify or suspend this MAP policy in whole or in part by notifying all resellers of the duration and nature of the change.
6. Intentional and/or repeated failure to abide by this MAP policy will result in penalties and may result in loss of authorized reseller status for the Carplanet line of products.
